OPEN CONTAINER PERMIT APPLICATION AND AGREEMENT

If you would like to provide alcoholic beverages to attendees of your outside event at no cost and it is a private, invite-only event (family or school reunion or company picnic or event) you must apply for an Open Container Permit and agree as set forth below and provide the following:

- Your proposed procedures to ensure that underage persons and persons under the influence of alcohol will not obtain or consume fermented malt or alcoholic beverages served at the event.
- Your proposed procedures indicating how applicant will secure and supervise the area and participants.
- Applicant, by signing this application, agrees to provide sandwiches and other food services at the event during the time of alcohol consumption in an amount sufficient to serve the number of persons anticipated to attend.
- Applicant, by signing this application, agrees that they are personally responsible for and provide financial guarantees to ensure cleaning, trash disposal or repairs necessary as a result of the event (The amount of financial guarantee will be determined by the City).
- Applicant, by signing this application, agrees to indemnify, defend and hold the City of Torrington, its officers, officials, Mayor, councilmen, attorney, employees and agents harmless for any and all liability, damages, injuries, lawsuits, demands and claims arising from the event.
